## **Agreement for Waiver and Release, Assumption of Risks, and Indemnification**

*This document affects your legal rights. Please read it carefully.*

***No Skateboarding will be permitted without the proper completion of this document.***

I \_\_\_\_\_, being above the age of 18, or the parent or legal guardian of the above individual who is under the age of 18, agree as follows:

I acknowledge and understand that skateboarding and other roller sports are hazardous and dangerous activities that require strenuous exercise and various degrees of skill and experience for the different skating surfaces and venues. I understand that these activities can result in serious injury to the person and damage to property, and voluntarily assume any and all risks of loss, damage, or injury while on the premises.

I am aware of the risks, hazards, and dangers of personal injury, death and disability inherent in entering the premises and participating in any roller sport event. I am aware of the unusual risks, hazards and dangers of injury, death and disability that increase when using ramps, half pipes, inclines/declines, bowls, or any other structure or device. I also understand that these risks, hazards, and dangers are further increased when other persons, whether of the same level of experience or skill, are using the same facilities.

In consideration for the admission, viewing privileges and use of the facilities of the City of Chattanooga Parks and Recreation Department. I hereby agree to release and forever discharge the City of Chattanooga Parks and Recreation Department and the City of Chattanooga, and their agents, employees, officers, and all other persons or entities acting on their behalf, from any and all claims, actions, damages, liability, costs or expenses and attorney fees which are related to arise out of , or are in any way connected to my participation or use of the skate facility(either in the interior or the exterior), use of equipment or property supplied by the City of Chattanooga Parks and Recreation Department or my presence upon the premises, whether or not such claims, actions, damages, liability, costs or expenses are caused by the negligence of the City of Chattanooga Parks and Recreation Department , the City of Chattanooga or landlord.

By this Agreement, it is my intention to surrender and waive any rights to sue or exercise any legal right to seek damages from the City of Chattanooga Parks and Recreation Department, the City of Chattanooga and their agents, employees, officers, and the other persons or entities acting on their behalf.

I acknowledge that my participation in or the viewing and spectating of activities at the City of Chattanooga Parks and Recreation Department is strictly voluntary in spite of the risks and dangers and that no one is forcing me to participate or view and/or spectate.

I agree to indemnify, hold harmless and defend the City of Chattanooga Parks and Recreation Department, the City of Chattanooga, and their agents, employees, officers, and all other persons or entities acting on their behalf, from any and all claims, actions, damages, liability, costs or expenses and attorney fees of any spectator, other member or third partying connection with or arising out of my involvement or participation in any activity at the City of Chattanooga Parks and Recreation department.

I give my consent and permission to the City of Chattanooga Parks and Recreation Department to obtain on my behalf of myself or my minor child any emergency medical treatment in case of sickness accident or injury and to secure such medical attention at my expense.

I agree that this Agreement shall apply to my participating in any and all City of Chattanooga Parks and Recreation Department activities and programs, including but not limited to, open skating, skateboarding, other roller sport activities, practice sessions, instructional sessions., competitions and activities directed by any representative of the City of Chattanooga Parks and Recreation Department, including viewing or spectating of any of the aforementioned activities.

This Agreement shall cover all of the aforementioned activities regardless of whether the activities are conducted inside the building, outside the building or an other location where activities sponsored by the City of Chattanooga Parks and Recreation Department may take place.

This Agreement shall be effective and binding upon my heirs, agents, personal representatives and assigns.

I hereby certify that I am over 18 years of age or I am the parent or legal guardian of the minor member listed above.

I have carefully read the foregoing and acknowledge that I understand and agree to all of the above terms and conditions.

I have had the opportunity to ask any and all questions regarding this agreement and the effect of the same.

I am aware that by signing this Agreement, I assume all risks and waive and release certain substantial rights that I may have or possess.
