19                  COUNCILMAN RICO: Move to approve.

20                  COUNCILWOMAN ROBINSON: Second.

21                  CHAIRMAN BENSON: Okay. It's certain  
22 there's no one out there who wants to address  
23 anybody on 3A? Been moved and seconded, then, to  
24 approve the Plan of Services. It's pretty much  
25 the same kind of services we've heard for all

1 districts.

2                   Okay. We'll call the question. All  
3 in favor, let it be known by saying aye.

4                   COUNCIL MEMBERS: Aye.

5                   CHAIRMAN BENSON: Opposed, no.

6 Carried. Now we go to the public hearing for --

7                   MS. O'NEAL: No.

8                   MR. MCMAHAN: That's Thursday night.

9                   CHAIRMAN BENSON: 4B area will be  
10 Thursday evening at 6:00 p.m. I know some of you
