Allied Arts of Greater Chattanooga Responsibilities:

1. Allied Arts shall provide funding in the amount of \$5,500.00 to the City of Chattanooga for the reimbursement cost of the Art Elements being constructed per the City contract with Yerbey Concrete Construction for this project, and as agreed per the email received from Sarah Morgan on September 17, 2012, attached.

City Responsibilities:


1. The City shall install as part of its contract with Yerbey Concrete Construction park enhancement elements to accent Clearscapes, Art Element pieces in the park.
