A RESOLUTION AUTHORIZING THE APPOINTMENT OF OLIVIA SWAFFORD AS SPECIAL POLICE OFFICER (UNARMED) FOR ANIMAL CARE TRUST D/B/A McKAMEY ANIMAL CARE AND ADOPTION CENTER, INC., TO DO SPECIAL DUTY AS PRESCRIBED HEREIN, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That OLIVIA SWAFFORD be and is hereby appointed as special police officer (unarmed) for Animal Care Trust d/b/a McKamey Animal Care and Adoption Center, Inc., subject to certain conditions and restrictions:

1. That said special police officer shall have, possess and exercise every power, except as hereinafter limited, granted by the statutes of the State of Tennessee or the City of Chattanooga to regular police officer of the City of Chattanooga necessary in the performance of their duties. Such powers and performance of duties by said special police officer are expressly limited to the performance of duties in her position for Animal Care Trust d/b/a McKamey Animal Care and Adoption Center, Inc.

2. That said special police officer shall not be considered an employee of the Chattanooga Police Department, nor shall be entitled to benefits afforded regular police officer of the City, and shall in all respects be considered employees of Animal Care Trust d/b/a McKamey Animal Care and Adoption Center, Inc.

3. That such appointment shall expire upon termination of said special police officer's employment by Animal Care Trust d/b/a McKamey Animal Care and Adoption Center, Inc. Notwithstanding any other provision herein, the City Council of the City of Chattanooga shall have the right to cancel such appointment at any time.
