A RESOLUTION AUTHORIZING THE ADMINISTRATOR OF THE ECONOMIC AND COMMUNITY DEVELOPMENT DEPARTMENT TO ACCEPT AN EMERGENCY SOLUTIONS GRANT FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, IN THE AMOUNT OF ONE HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED FIFTY-TWO DOLLARS (\$118,552.00).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Administrator of the Economic and Community Development Department is hereby authorized to accept an Emergency Solutions Grant from the U.S. Department of Housing and Urban Development, in the amount of \$118,552.00.

EMERGENCY SOLUTIONS GRANT

The Emergency Solutions Grant (formerly Emergency Shelter Grant) provides funding to: (1) engage homeless individuals and families living on the street; (2) improve the number and quality of emergency shelters for homeless individuals and families; (3) help operate these shelters; (4) provide essential services to shelter residents, (5) rapidly re-house homeless individuals and families, and (6) prevent families and individuals from becoming homeless.

The City of Chattanooga for many years received the ESG allocation (usually around \$84,000) directly from the U. S. Department of Housing and Urban Development. However, in 2009, HUD changed the formula by which funding was allocated. The 2000 Census reflected a change in Chattanooga's population, and as a result, the City lost its eligibility to apply for direct ESG funding from HUD. The City applied for the \$84,000 ESG funding through the Tennessee Housing Development Agency beginning with fiscal year 2009-2010, and continued to do so until 2012. THDA's most recent award to the City was for \$84,000 for fiscal year 3/1/13 – 2/28/14.

HUD revised its formula for the 2013-2014 fiscal year, and the City regained its eligibility to receive the direct allocation of ESG funds from HUD.

HUD has awarded the City \$118,552 for fiscal year 7/1/13 – 6/30/14.
