AN ORDINANCE AMENDING CHATTANOOGA CITY CODE TO DELETE ALL REFERENCES TO THE HUMAN SERVICES DEPARTMENT IN ARTICLE IX, CHAPTERS 2-641 THROUGH 2-660 RELATIVE TO THE RENAMED AND REORGANIZED CHATTANOOGA YOUTH AND FAMILY DEVELOPMENT DEPARTMENT; ARTICLE III, DIVISIONS 1 AND 2, CHAPTERS 2-138, 2-139, AND 2-143 RELATIVE TO HUMAN RESOURCES; ARTICLE I, CHAPTERS 24-30 AND 24-37; ARTICLE II, CHAPTER 24-63, AND ARTICLE VII, DIVISION 2, CHAPTER 35-252 RELATIVE TO TRANSPORTATION; ARTICLE 1, CHAPTERS 32-13 AND 32-14; AND ARTICLE V, DIVISION 18, CHAPTER 38-285 RELATIVE TO ECONOMIC AND COMMUNITY DEVELOPMENT; ARTICLE XII, CHAPTER 11-377; ARTICLE I, CHAPTERS 26-7, 26-13, 26-14 RELATIVE TO PUBLIC WORKS; ARTICLE VI, CHAPTERS 2-581 AND 2-584, AND ARTICLE I, CHAPTER 26-24 RELATIVE TO GENERAL SERVICES TO BE CONSISTENT WITH NEW ADMINISTRATIVE DEPARTMENTS EXISTING IN THE CURRENT ADMINISTRATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE:

SECTION 1. That all references within Article IX, Sections 2-641 through 2-660 of the Chattanooga City Code referring to the **“Human Services Board”** or **“Human Services Department”** are hereby deleted and renamed and reorganized at the request of the Mayor as the **“Chattanooga Youth and Family Development Board”** or **“Chattanooga Youth and Family Development Department”** to be consistent with new administrative departments existing in the current administration.

SECTION 2. That all references within Article III, Divisions 1 and 2, Chapters 2-138, 2-139, and 2-143 of the Chattanooga City Code referring to **“Personnel Director” or “Personnel Department”** are hereby deleted and renamed and reorganized at the request of the Mayor as the **“Human Resources Director” or “Human Resources Department”** to be consistent with new administrative departments existing in the current administration.

SECTION 3. That all references within Article I, Chapters 24-30 and 24-37; Article II, Chapter 24-63; and Article VII, Division 2, Chapter 35-252 of the Chattanooga City Code previously referring to **“Administrator of Public Works” or “Public Works Department”** are hereby deleted and renamed and reorganized at the request of the Mayor as the **“Administrator of the Transportation Department” or “Transportation Department”** to be consistent with new administrative departments existing in the current administration.

SECTION 4. That all references within Article 1, Chapters 32-13 and 32-14; and Article V, Division 18, Chapter 38-285 of the Chattanooga City Code previously referring to the **“Administrator of Public Works” or “Public Works Department”** are hereby deleted and renamed and reorganized at the request of the Mayor as the **“Administrator of Economic and Community Development” or “Economic and Community Development Department”** to be consistent with new administrative departments existing in the current administration.

SECTION 5. That all references within Article XII, Chapter 11-377 and Article 1, Chapters 26-7, 26-13, and 26-14 of the Chattanooga City Code referring to **“Administrator of Parks and Recreation” or “Parks and Recreation”** are hereby deleted and renamed and reorganized at the request of the Mayor as the **“Administrator of Public Works” or “Public Works Department”** to be consistent with new administrative departments existing in the current administration.

SECTION 6. That all references within Article VI, Chapter 2-581 and 2-584, and Article I, Chapter 26-24 of the Chattanooga City Code referring to “**Administrator of Parks and Recreation**” or “**Parks and Recreation**” are hereby deleted and renamed and reorganized at the request of the Mayor as the “**Director of General Services**” or “**General Services Department**” to be consistent with new administrative departments existing in the current administration.

SECTION 7. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.
