BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Chief of the Chattanooga Fire Department be and is hereby authorized to apply for and, if awarded, accept a 2013 Assistance to Firefighters Grant issued by the Federal Emergency Management Agency (FEMA), in the amount of \$50,250.00, with the City's match in the amount of \$5,025.00.

The funds will be used to purchase forty-two (42) gas monitor kits and two (2) gas monitor calibration units to replace and upgrade the department's current gas monitors. The grant will require a match of ten (10%) percent by the City.
