

**AMENDMENT NO. 3 TO INDEPENDENT CONTRACTOR AGREEMENT FOR
PROFESSIONAL SERVICES RELATED TO EPA REVOLVING LOAN FUND GRANT**

This Amendment No. 3 to the Independent Contractor Agreement (the "Amendment") is made effective the first day of June, 2013 (the "Effective Date"), by and between BrightBridge, Inc., (hereinafter "Contractor" or "BrightBridge"), and the City of Chattanooga, a municipal corporation, (hereinafter "the City").

RECITALS

WHEREAS, an existing agreement (the "Agreement") effective the 1st day of June, 2009 through May 30, 2011 is in place between the Contractor and the City, defining the roles and responsibilities of the two parties; and

WHEREAS, the parties agree to amend the Agreement by extending the duration for an additional one (1) year period.

NOW, THEREFORE, in consideration of the mutual covenants and agreements, the parties hereby agree as follows:

1. The Agreement was previously amended for an additional fourteen (14) month year term beginning June 1, 2011 and ending May 30, 2012.
2. The Agreement had Amendment No. 2 to the Agreement for an additional one (1) year term beginning June 1, 2012 and ending May 30, 2013.
3. The parties desire to extend this Agreement for an additional fourteen (14) months term beginning June 1, 2013 and ending July 31, 2014.
4. The parties agree that this Amendment No. 3 does not change the total contractor payment amount to BrightBridge in the amount of \$191,000.00 for the period beginning June 1, 2013 and ending on July 31, 2014.
5. No other modifications, amendments or changes of the provisions of the Agreement are to be affected by this Amendment No. 3.
