A RESOLUTION AUTHORIZING THE ADMINISTRATOR FOR THE DEPARTMENT OF TRANSPORTATION TO APPLY FOR AND, IF AWARDED, ACCEPT A GRANT FROM THE TENNESSEE DEPARTMENT OF TRANSPORTATION (TDOT) FOR FISCAL YEAR 2015 TRANSPORTATION ALTERNATIVES PROGRAM FOR MULTI-USE PATH AND BICYCLE FACILITY IMPROVEMENTS ALONG SHALLOWFORD ROAD AND CAINE LANE AS AN EXTENSION TO THE SOUTH CHICKAMAUGA CREEK GREENWAY, FOR AN AMOUNT TO BE DETERMINED, WITH EIGHTY (80%) PERCENT BEING THE TDOT SHARE AND TWENTY (20%) PERCENT BEING REQUIRED FROM THE CITY AS LOCAL MATCHING FUNDS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Administrator for the Department of Transportation is hereby authorized to apply for and, if awarded, accept a grant from the Tennessee Department of Transportation (TDOT) for Fiscal Year 2015 Transportation Alternatives Program for multi-use path and bicycle facility improvements along Shallowford Road and Caine Lane as an extension to the South Chickamauga Creek Greenway, for an amount to be determined, with 80% being the TDOT share and 20% being required from the City as local matching funds.


