A RESOLUTION AUTHORIZING THE WAIVER OF THE DEMOLITION PERMIT FEE IN THE AMOUNT OF ONE HUNDRED FORTY DOLLARS (\$140.00) AND THE LAND DISTURBING ACTIVITY PERMIT FEE IN THE AMOUNT OF ONE HUNDRED FIFTEEN DOLLARS (\$115.00), INCLUDING DISPOSAL FEES FOR CONSTRUCTION DEBRIS AT LANDFILL IN THE AMOUNT OF ONE THOUSAND DOLLARS (\$1,000.00), CONCERNING A BURNED HOME LOCATED AT 220 HOUSER STREET, CHATTANOOGA, TN 37405, FOR A TOTAL AMOUNT NOT TO EXCEED ONE THOUSAND TWO HUNDRED FIFTY-FIVE DOLLARS (\$1,255.00).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That it hereby authorizes the waiver of the Demolition Permit Fee in the amount of \$140.00 and the Land Disturbing Activity Permit Fee in the amount of \$115.00, including disposal fees for construction debris at landfill in the amount of \$1,000.00, concerning a burned home located at 220 Houser Street, Chattanooga, TN 37405, for a total amount not to exceed \$1,255.00.
