HEREIN, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA,  
TENNESSEE, That LESLIE STOKES AND CAROLYN MAYNER be and are hereby  
appointed as special police officers for the McKamey Animal Center, subject to certain  
conditions and restrictions:

1. That said special police officers shall have, possess and exercise every power  
granted by the statutes of the State of Tennessee or the City of Chattanooga to regular police  
officers of the City of Chattanooga necessary in the performance of their duties, except they shall  
not be allowed to carry a firearm. Such powers and performance of duties by said special police  
officers are expressly limited to the performance of duties in their position as Animal Service  
Officer, for the McKamey Animal Center.

2. That said special police officers shall not be considered regular police officers and  
shall not be entitled to any benefits afforded regular police officers.

3. That such appointments shall expire upon termination of said special police  
officers' employment by the McKamey Animal Center. Notwithstanding any other provision  
herein, the City Council of the City of Chattanooga shall have the right to cancel such  
appointment at any time.
