ORDINANCE NO. _____

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 26, SECTIONS 26-17, 26-21, 26-22, 26-23, 26-24, 26-25, 26-26, 26-27, 26-28, 26-29, 26-30 AND 26-34 TO AMEND THE CODE AND ESTABLISH THE EVENT FEES FOR USAGE OF VARIOUS CHATTANOOGA YOUTH AND FAMILY DEVELOPMENT FACILITIES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE:

SECTION 1. That Chattanooga City Code, Part II, Chapter 26 is amended by deleting “Brainerd Golf Course” and inserting in lieu thereof “Municipal Golf Courses.”

SECTION 2. That Chattanooga City Code, Part II, Chapter 26, Section 26-17 (3) is amended by deleting “Parks, Recreation, Arts & Culture” and inserting in lieu thereof “Public Works.”

SECTION 3. That Chattanooga City Code, Part II, Chapter 26, Section 26-17 (4) is amended by deleting “head of the recreation department” and inserting in lieu thereof “Administrator of the Department of Public Works.”

SECTION 4. That Chattanooga City Code, Part II, Chapter 26, Section 26-21 is amended by deleting “Parks, Recreation, Arts & Culture” and inserting in lieu thereof “Youth and Family Development.”

SECTION 5. That Chattanooga City Code, Part II, Chapter 26, Sections 26-22, 26-23, 26-24, 26-25, 26-26, 26-27, 26-28, 26-29, 26-30, 26-31 and 26-34 are amended by deleting the Sections in their entirety and inserting in lieu thereof the following:

Sec. 26-22, Reserved.

Sec. 26-23. Rental Rates for Municipal Parks

City sponsored events require the approval of the Mayor or Department of Public Works Administrator or his designee. The following rental rates and fee schedule shall apply to events in these designated municipal parks:

A. Riverfront Parks (500 or more participants):

1. Must secure a *License Agreement* through waterfront management organization.
2. Refundable damage deposit will be required on all events.
3. Rates shown are by event.
4. Event duration is a maximum of three (3) consecutive days without express written approval by the Administrator of the Department of Public Works or his designee.

CATEGORY 1

No sales, admission fees, entry fees, pledges, or donations collected on site. [And] No concession or merchandise vending on site. Funds to produce the event may be obtained from grants, donations, or sales that occur off site prior to the event.

CATEGORY 2

Events where sales, and/or concessions, and/or entry fees, are charged in order to participate.
