A RESOLUTION AUTHORIZING THE ADMINISTRATOR OF THE DEPARTMENT OF PARKS AND RECREATION TO EXECUTE A TWO (2) YEAR LICENSE AGREEMENT WITH RIVER CITY DUCKS, LLC, FOR THE USE OF THE ROSS' LANDING RAMP TO ACCESS THE TENNESSEE RIVER FOR THE OPERATION OF AN AMPHIBIOUS VEHICLE IN AN AMOUNT OF FOUR HUNDRED FIFTY DOLLARS (\$450.00) PER MONTH DURING THE MONTHS OF MARCH 1ST THROUGH OCTOBER 31ST.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Administrator of the Department of Parks and Recreation is hereby authorized to execute a two (2) year License Agreement with River City Ducks, LLC, for the use of the Ross' Landing Ramp to access the Tennessee River for the operation of an amphibious vehicle in an amount of \$450.00 per month during the months of March 1st through October 31st.
