# Memorandum of Understanding

## 2015 Lexia Reading Software Package

City of Chattanooga Department of Youth and Family Development

and

United Way of Greater Chattanooga

This Memorandum of Understanding (“MOU”) memorializes the agreement between the City of Chattanooga Department of Youth and Family Development (“YFD”) and United Way of Greater Chattanooga (“United Way”) to fund the Lexia Reading software package.

### Background and Purpose
