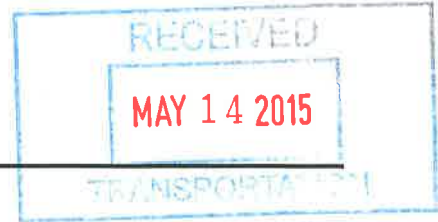

PARTNERSHIP AGREEMENT

T-14-027-805



The City of Chattanooga and **The Broadway Group** agree to enter into a Partnership Agreement for the property located at 3210 Wilcox Boulevard; this agreement shall be known as Project No. T-14-027-805. The City and **The Broadway Group** agree that each party has certain responsibilities to make this project succeed. The following responsibilities of each party are as follows:

The Broadway Group Responsibilities:

1. **The Broadway Group** shall construct the streetscape along all public streets that are part of the Wilcox Boulevard Dollar General project located at 3210 Wilcox Boulevard. The work shall include foundations for the Pedestrian Light Poles (PLP), conduits and handhold boxes.
2. **The Broadway Group** shall provide a contribution of \$7,083.80 towards the cost of (5) PLP's and light fixtures.

City Responsibilities:

1. The City is the sole owner of the Pedestrian Light Poles and thus is the only entity approved to order the poles fabricated by Sun Valley, by a competitive bid process. Once payment has been received by **The Broadway Group** the poles shall be ordered.
2. The City shall be responsible for the installation of the electrical wiring, the PLP's, and light fixtures at a cost of \$1,416.76 each.
3. The City and the Electric Power Board of Chattanooga (EPB) will be responsible for maintenance of all standard light fixtures and poles within the public rights-of-way, as well as the costs for electricity usage for said fixtures.

The City and **The Broadway Group** are in agreement to the above terms as they pertain to the Wilcox Boulevard Streetscape Project and by the execution of signatures below enter into a Partnership Agreement.
