A RESOLUTION AUTHORIZING THE APPOINTMENT OF SHAUN MILLSAPS AS SPECIAL POLICE OFFICER (UNARMED) FOR THE CITY OF CHATTANOOGA DEPARTMENT OF PUBLIC WORKS, WASTE WATER DIVISION, TO DO SPECIAL DUTIES AS PRESCRIBED HEREIN, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That SHAUN MILLSAPS be and is hereby appointed as a special police officer for the City of Chattanooga Department of Public Works, Waste Water Division, subject to certain conditions and restrictions:

1. That said special police officer shall have, possess and exercise every power granted by the statutes of the State of Tennessee or the City of Chattanooga to regular police officers of the City of Chattanooga necessary in the performance of his duty, except he shall not be allowed to carry a firearm. Such powers and performance of duties by said special police officer are expressly limited to the performance of duties of Pretreatment Inspector for the Department of Public Works, Waste Water Division, for the City of Chattanooga.

2. That said special police officer shall not be considered a regular police officer and shall not be entitled to any benefits afforded regular police officers.

3. That such appointment shall expire upon termination of said special police officer's employment by the Department of Public Works, Waste Water Division, for the City of Chattanooga. Notwithstanding any other provision herein, the City Council of the City of Chattanooga shall have the right to cancel such appointment at any time.
