Such powers and performance of duties by said special police officer are expressly limited to the performance of duties in his position as Animal Services Officer, for the McKamey Animal Center.
- 2. That said special police officer shall not be considered a regular police officer and shall not be entitled to any benefits afforded regular police officers.
- 3. That such appointment shall expire upon termination of said special police officer's employment by the McKamey Animal Center. Notwithstanding any other provision herein, the City Council of the City of Chattanooga shall have the right to cancel such appointment at any time.
