RE: PROPOSAL FOR EXTENSION OF CONSTRUCTION ADMINISTRATION / OBSERVATION SERVICES FOR THE ROSS'S LANDING PARK IMPROVEMENTS PROJECT THROUGH JANUARY 1, 2016

Dear Mr. Ogle:

It appears we're on the home stretch in completing the Ross's Landing Park, and we're thankful to have been part of the process. From our initial involvement in the condition assessment, we've looked forward to assisting the City of Chattanooga (City) in achieving its goal of a restored downtown riverfront park.

HDR's original Bidding / Construction Administration / Observation Services contract with the City was adopted by City Council on May 27, 2014 (Resolution No. 27877).

Bid phase services began soon after the submittal of contract documents to the City on April 25, 2014. Bids were opened June 5, 2014, and the construction contract awarded to Smith Contractors, Inc. (Contractor). Notice to Proceed was issued July 23, 2014, with the expected construction (boots-on-the-ground) start date of November 3, 2014. The original scheduled construction end date was May 1, 2015.

The Contractor was not able to complete the work by the original contracted end date. He received an extension of time which put his end date at September 11, 2015. Additional work has been authorized which will now put the expected construction end date on January 1, 2016.

HDR's first request for a time extension (Change Request #2 – authorized 07/20/15) was authorized through July 31, 2015. This second time extension request will allow for construction administration and observation services through January 1, 2016.

Note that construction closeout services (punch list walkthrough, record drawings, etc.) were included in the Original Contract. These services will still be performed at the conclusion of the field

work; no costs for these are included in this extension request. See the table below for further clarity.

SCOPE OF WORK

Our scope of work will continue uninterrupted, and will continue to include the following:

- Project Management and Controls. Project management and controls will be used to schedule the work, assign staff, and communicate the status of the project to the City of Chattanooga. This task assumes 8 hours/week for a Project Manager (PM).
- Construction Administration/Observation Services. We will provide a part-time (24 hours/week) onsite Resident Project Representative (RPR) during the remaining period of construction.

The Engineer of Record (EOR) will continue to make monthly site visits for the duration of the construction period. The EOR will also participate in the final inspection and issue a Certificate of Completion to the City for the project.

The RPR will review "red-line" drawings, and based on those, prepare a set of record drawings for delivery to the City.

The following is a general timeline, based on the current construction completion date of January 1, 2016, indicating the periods of time when our efforts will be either full- or part-time.

PROPOSED FEES

In order to accomplish the work described above in the Scope of Work above, HDR proposes to provide these services on a Lump Sum Basis for an additional fee of \$127,150. The basis for our estimate is provided in Attachment A – *Project Proposal Summary*. We understand the terms of this project will be covered via an amendment to our existing contract No. E-10-012-101, 21st Century Waterfront Ross's Landing: Riverfront Parkway Phase I Evaluation – Investigation, as approved by City Council Resolution No. 26622.

AUTHORIZATION

If you concur with this proposal, please prepare a Change Request Form (CRF) for our signature in preparation for execution. Any work outside the Scope will be done, with authorization from you, via a formal CRF, in accordance with the *HDR's Schedule of Rates (No. 1-15)* as found in Attachment B, or agreed to lump sum fee. This proposal is valid for 45 days from the date of this document.

Invoicing will continue to be submitted on a monthly basis with the monthly status reports to provide updates regarding completed progress.

HDR issues new rate schedules in January of each year. Based on the anticipated project execution schedule, we have included a five-percent contingency to cover the anticipated increase in fees for the work occurring after January 1, 2016.
