BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Mayor, as the Certifying Officer for HUD Environmental Review Procedures, be and is hereby authorized to designate the Administrator of the Department of Neighborhood Services and Community Development and, in his/her absence, the Manager of Community Development to sign documents relative to the environmental review process as required by federal regulations effective June 1, 2008.
