Whereas, The City of Chattanooga, TN and the State of Tennessee Department of Environment and Conservation, entered into Contract in Lieu of Performance Bond (Copy attached) for proper operation and closure and/ or post-closure of the City of Chattanooga Summit Sanitary Landfill. Register Number SNL 33-0035; and

Whereas, said contract included a provision allowing the Commissioner of Environment and Conservation to collect up to \$2,130,619.00 from any funds being disbursed or to be disbursed from the State to the City of Chattanooga, TN as financial assurance for said proper operation, closure and post-closure; and

Whereas, the State and The City of Chattanooga desire to change the amount of said financial assurance from \$2,130,619.00 to \$1,990,325.78

The Figure "2,130,619.00" is deleted and the figure "\$1,990,325.78" is substituted in lieu thereof.
