## **HEARING: KENNETH FREEMAN**

City Attorney McMahan stated the request for hearing from Detective Kenneth Freeman has been received to appeal his 28-day suspension without pay.

Councilman Benson stated that his point is extraneous to actually selecting someone however he wanted to say what he had to say. He stated that it is getting harder and harder to find a panel to serve (on hearings) and suggested the Council seriously think about putting before the city in the next coming election a proposal to change the *Code* so each Council person elected can either serve or select a person to represent himself or herself. He stated in his case he has two-to-three retired Federal judges who would love to serve all Monday mornings! He stated the longer he serves on the Council the more he finds himself in conflict of interest sitting in judgment of some of his peers.

## **HEARING: KENNETH FREEMAN (Continued)**

Councilman Benson asked that the Council think about it and expressed knowing Councilman Pierce feels differently. He stated it is his idea that the Council person can serve or have his appointee serve. He asked if that is possible.

City Attorney McMahan stated it is possible if the matter is approved by referendum.

At this point City Attorney McMahan reminded Council members of the hearings that are already scheduled for February and March and related the available dates prior to the new Council coming on board. Initially, March 9 was suggested as the date for the hearing however Councilman Pierce suggested a March 2 date.

Councilwoman Berz strongly suggested the Council skip the March 2 date, reminding them that March 2 is the day before election and a lot of energies would be going on.

A hearing for Mr. Freeman was scheduled for Monday, March 9 beginning at 9 a.m. with Councilmen Berz, Rico and Pierce as the panel; an alternate was not selected.

# CANCELLATION OF MARCH 3 COMMITTEE AND COUNCIL MEETINGS

Chairman Bennett stated that March 3 is the city election date and the Council has not usually met on election evening.

Chairman Bennett stated that a special presentation to the Council by Gene Hyde regarding the Climate Control Report is scheduled for Tuesday, February 24 at 2 p.m.

## **RECOGNITION OF WILMA AKRIDGE**

Chairman Bennett recognized the presence of Wilma Akridge of the Hill City Neighborhood Association.

#### **CHARLES PAYNE**

Charles Payne, President of the Chattanooga Neighborhood Association Council (CNAC) and President of the Washington Hills Neighborhood Association stated that he was before the Council today as requested by the governing board of CNAC to ask the Council for assistance regarding persons in their districts. He stated CNAC was actually set up in 2001 to provide representation from all nine neighborhood districts and noted that they do not have all the members they would like to have in the organization. He noted that Councilman Gilbert went through CNAC during its initial stage and acknowledged the involvement of Wilma Akridge and Councilwoman Bennett, who helped get the organization started and expressed thanks to her. He asked the Council members to give CNAC some assistance in recommending persons adding that he knows Council members can not ask persons to participate if they are not willing to do so.

## **CHARLES PAYNE (Continued)**

Mr. Payne stated that they have good activities in the community and work closely with the Neighborhood Leadership Institute. He stated Districts 2, 3 and 6 have no representation at all and each district is supposed to have three representatives for a total of 27 members. He stated there is a depletion of members due to attrition, as well as some leaving due to sickness. He stated that they are doing great things and working in concert with the city in an effort to address crime, blight and other things they see. He concluded his comments by asking the Council to give a recommendation of leaders within their districts.

Chairman Bennett asked how often the group met and the time frame.

Mr. Payne responded that they meet for about an hour on the fourth Monday at 6 p.m. at the Community Foundation. He stated they have invited the Mayor, Council persons and others to come and have had Dr. Amanda of the McKamey Center present, as well. He stated they have exciting guests to come in and give information and did some research for CARTA. He reiterated that they do good things and plan to have a retreat in the spring.

Councilwoman Berz stated that she did not know District 6 needed people on the Board and asked if he could provide packets of information for the three persons she will refer. She stated the packets would be very helpful and (she) would get three people right away. Mr. Payne acknowledged that he would get the packets of information to her on tomorrow.

Chairman Bennett stated that it would be helpful to use additional packets so when vacancies occur Council members will have them available and will know what their "homework" is.

Mr. Payne expressed thanks to the Council for allowing him to address them.

Chairman Bennett thanked him for making the Council aware of the need.

Councilwoman Robinson thanked Mr. Payne for what the organization is doing; that they are doing great work!

Mr. Payne stated District 5 has a good group and is covered with all three representatives; that some districts only have one or two members.
