City Council Building Chattanooga, Tennessee May 19, 2009 6:00 p.m.

Chairman Benson called the meeting of the Chattanooga Council to order with Councilmen Berz, Gilbert, Ladd, McGary, Murphy, Rico, Robinson and Scott present. City Attorney Michael McMahan, Management Analyst Randy Burns and Council Clerk Carol O'Neal were also present.

PLEDGE OF ALLEGIANCE/INVOCATION

Following the Pledge of Allegiance by Interim Fire Chief Randy Parker, Adm. Steve Leach gave the invocation for the evening.

MINUTE APPROVAL

On motion of Councilwoman Robinson, seconded by Councilman Rico, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION: "PUBLIC WORKS WEEK"

Mayor Littlefield recognized public works employees present and asked that they join him at the lectern in recognition of "Public Works Week". He stated nothing gives him more pleasure than to recognize public works employees explaining when he was part of the City Commission as Public Works Commissioner he realized how valuable that part of government is. He stated the department does not get many accolades when the streets are perfect and everything is as it should be, however when garbage is not picked up they get a lot of complaints, noting that the departmental employees work hard, tireless hours. In recognition of the men and women of the department he read a proclamation proclaiming "Public Works Week". After reading the Proclamation he reminded the Council that today, just over a year ago, these individuals and their counterparts at the county worked at Enterprise South as a unified team and are greatly responsible for the progress that has taken place. At this time the department was recognized with a standing ovation by all in attendance.

Adm. Leach expressed thanks to the Council for their recognition, as well as the Mayor's proclamation. He stated the employees within the department work hard day-in-and-out, 365 days a year, 24 hours a day and it does not matter what conditions are out there! He stated in speaking from administration, he knows they are "worker bees", are really dedicated to this community and deserve this recognition.

Chairman Benson stated public works is the heart of the service to the citizens and as part of their service they are in our homes every single week efficiently working for us. He acknowledged Jim Templeton and his family's heritage in the department relative to his father and grandfather, noting that it was 1930 when his (Templeton's) grandfather began working with the city.

Councilman Murphy commented at this time and asked if the Council really needs to authorize the Mayor to raise money for a good cause.

Mr. Johnson replied that it is a requirement of the *Charter*.

City Attorney McMahan clarified there must be authorization if the Mayor is accepting funds for city-related matters.

DWIGHT A. MANGHANE

Dwight A. Manghane stated that he works for the department of public works and his issue references holidays when they have to come in to work. He stated they do get paid for the day but it seems time is deducted; that they lose time for the day and he does not think that is right. He explained by giving the example of his personal time – that he will lose ten (10) hours on Monday as he has to work on Monday, however, if he works seven (7) hours he will get paid for the day for coming to work. He stated he is the employee and administration is the employer and if he comes in and performs his time his personal leave should not be touched and that is what is taking place. He prayerfully asked that the Council look into it and stop it; that it needs to be stopped as it is not right!

Chairman Benson expressed understanding but admitted he did not know the answer. He asked Adm. Donna Kelley to address the issue.

Adm. Donna Kelly stated in all departments there are some modifications as to how employees are treated on holidays. She stated in this case it is her belief without checking the record the issue is double time-and-a-half, which is customarily the way it is treated when an employee works on holidays – they receive double time-and-a-half; that they are actually paid time-and-a-half for working a holiday.

City Attorney McMahan stated that the question was if work is done on a holiday.

Mr. Manghane interjected that personal leave is taken way, to which Adm. Kelley responded "no", with Mr. Manghane emphasizing "it is".

Adm. Kelley explained a holiday is deducted if an employee is off on the holiday, not if they work on the holiday.

Chairman Benson asked that the Public Works Committee look into this.

Mr. Manghane insisted that employees are losing a day, but they are at work.

DWIGHT A. MANGHANE (Continued)

Adm. Kelley acknowledged that that is what she understands.

Mr. Manghane stated that is what is taking place, noting his wish that he had his check stub with him (to show proof the Council).

Chairman Benson again stated that the matter would be discussed in Public Works Committee and if there is a problem we would see what the solution is.

CAPTAIN DUNN

Captain Dunn stated that he was asked to address the issue regarding the ordinance requesting a change in nightclubs as he will not be in town next week and can not be present. He stated that it is his understanding there were questions last week and some of the misconception is that the ordinance does not have anything to do with existing businesses. He stated if a business is open and running it is grandfathered-in, however, if they close over 100 days they would have to comply with the new ordinance. He stated that it is his guess the easiest way to look at it is when they ask for up to 1,000 feet, they are looking at a business as it stands right now and get the business license, put in a club if it is within 500 feet. He stated all he is trying to do is answer questions that were raised and if they are any he would love to answer them now.

Chairman Benson expressed appreciation to Captain Dunn for his response.

JEFF BERNSTEIN

Jeff Bernstein of 3922 Volunteer Drive acknowledged that this is a tough budget year and it is his understanding city employee insurance rates are going up as of July 1. He stated there is a rumor there are no pay raises, however, nothing has been confirmed and it is up to the Council. He stated in listening in committee today with reference to recovery funds coming into the city, he agrees with a lot of projects and some pertaining to Volkswagen are very good. He stated this means there is money in the budget from state or city funds and now we are getting federal money and asked if this would free city money up if federal money is being used for projects. He stated in looking at this there may be a way to give some sort of compensation; that he understands the budget is tight and this is an opportune time to reward employees with funds that otherwise would have been used for city projects in the interim due to federal monies coming into Chattanooga.

JEFF BERNSTEIN (Continued)

Mr. Bernstein stated that he has been working with a lot of cities in the state in the Nashville, Memphis and Knoxville areas and encouraged the Council to look into that.

Chairman Benson adjourned the meeting of the Chattanooga Council until Tuesday, May 26, 2009 at 6:00 p.m.
