CITY COUNCIL BUILDING CHATTANOOGA, TN DECEMBER 15, 2009

Chairman Benson called the meeting of the Chattanooga City Council to order with Councilpersons Berz, Gilbert, Ladd, McGary, Murphy, Rico, Robinson and Scott present. City Attorney Michael McMahan, Management Analyst Randy Burns, and Shirley Crownover, Assistant Clerk to the Council, were also present.

PLEDGE OF ALLEGIANCE/ INVOCATION

The Pledge of Allegiance was led by Councilman Rico, followed by invocation.

MINUTE APPROVAL

On motion of Councilwoman Robinson, seconded by Councilman Rico, the minutes of the previous meeting were approved as published and signed in open meeting.

SPECIAL PRESENTATION PARKS AND RECREATION EMPLOYEE RECOGNITION

Adm. Larry Zehnder was present to recognize four of his employees, along with the help of Greta Hayes. He stated that he had four distinguished employees with over 30 years' service; that they gave service awards and pins but felt that a special tribute was warranted for these four employees. The first was **Ted Broyles**, who was hired in 1979 in the Division Construction Crew. He is now General Maintenance Supervisor and instrumental in getting Summit ready and a very valuable employee; **Cynthia Gates** also began her career in 1979 and was a Supervisor of Recreation.
