

City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES for May 14, 2013 6:00 PM

CALL TO ORDER

Chairman Yusuf Hakeem called the meeting to order with Vice Chairman Chip Henderson, Councilwoman Carol Berz and Councilmen Chris Anderson, Moses Freeman, Russell Gilbert, Larry Grohn, Jerry Mitchell and Ken Smith present.

Also present: Management Analyst Randy Burns; Deputy Clerk Nicole Gwyn and Council Support Specialist Cindy Patrick.

PLEDGE OF ALLEGIANCE

Councilwoman Carol Berz led the full attendance in the Pledge of Allegiance.

MEETING MINUTES APPROVAL

On motion of Councilman Anderson and seconded by Councilman Mitchell, the minutes of the previous meeting (May 7, 2013) were approved as published.
