RECOGNITION OF PERSONS WISHING TO ADDRESS COUNCIL (Non-Agenda Items)

Attorney Hinton read the rules of procedure for persons wishing to address the Council on non-agenda items. After which, Vice Chair Dr. Berz recognized the following persons:

- **Connie Griggs (McBrien Road)** Opposes moving the Senior Activities Center from Eastgate Town Center; asks the city to keep a facility specifically for senior activities.
 - o Mr. Goldberg responded to questions from Council on this matter.
- Donald Stewart (Signal Mountain) Opposes moving the Senior Activities Center from Eastgate Town Center; asks city to consider signing a 6-month lease with Eastgate in order to locate a new seniors activity center.
 - Mr. Goldberg responded to questions from Council on this matter.
- Joseph Gibson (Maryanne Lane) Voiced concerns about moving the Senior Activities
 Center; does not believe the city has done enough to keep the lease with Eastgate Town
 Center.
 - Mr. Goldberg responded to further questions from Council on this matter. He also indicated that Administration could have a report by next week on the Seniors Activity Center negotiations.
- Eleanor Cooper (Lindmere Drive) Opposes Tax Increments Financing (TIF) and asks the city to respect the court's decision regarding the Black Creek Mountain development; asks Council to establish criteria for TIFs and PILOTs (Payment In Lieu of Taxes).
- **Garnet Chapin (Chambliss Street)** Expressed support of TIFs; also expressed appreciation for two (2) days of ECD training on how to become a more active resident.
- Jeff Perlacky (West Hills Drive) Voiced concerns about off-duty police officers on Aetna Mountain Road at Black Creek; hopes that laws are being enforced for all, not just employees of Black Creek Mountain subdivision.

- Jefferson Hodge (McCallie Avenue) Opposes TIFs because of what he considers a
 "lack of democratic accessibility;" asks the city to support the court's recent decision on
 the Black Creek Mountain TIF.
- Gloria Griffith (District 7) Voiced concerns about errors in residential sewer billing; unable to reach anyone at the 1-800 customer service number to discuss billing discrepencies.
 - Councilman Anderson asked Ms. Griffith to meet with her and Molly Cooper (Mayor's Office) after tonight's meeting.
