

# City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES

August 12, 2014 6:00 PM

## **CALL TO ORDER**

Council Chairman Chip Henderson called the meeting to order with Vice Chair Dr. Carol Berz and Councilpersons Chris Anderson, Moses Freeman, Russell Gilbert, Larry Grohn, Yusuf Hakeem, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton, Management Analyst Randy Burns and Deputy Clerk Nicole Gwyn, CMC, were also present.

## PLEDGE OF ALLEGIANCE

Councilman Grohn led the assembly in the Pledge of Allegiance and read James 3:13-16 (NIV) from the Bible for the invocation.

## **ORDINANCE #12848**

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, SO AS TO REZONE PROPERTY LOCATED AT 7502 SHALLOWFORD ROAD, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-1 RESIDENTIAL ZONE AND R-4 SPECIAL ZONE TO C-4 PLANNED COMMERCE CENTER, SUBJECT TO CERTAIN CONDITIONS.

Greg Haynes, Regional Planning's Director of Development, made a presentation on this ordinance. The Applicant was present; however, there was no opposition present.

# **ORDINANCE #12849**

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 38, ZONING ORDINANCE, ARTICLE V, DIVISION 25, RESIDENTIAL PLANNED UNIT DEVELOPMENT, SECTION 38-393, PERMITTED USES, TO ALLOW ALL USES PERMITTED IN THE UNDERLYING ZONE(S) AND SECTION 38-398. PERMITTED DENSITY.

A discussion ensued in which Councilman Hakeem noted that the Applicant had asked for the ordinance to be withdrawn. Therefore, **Councilman Hakeem moved to deny**, seconded by Councilman Anderson. **The motion carried.** 

Later in the meeting, Regional Planning's Executive Director, John Bridger, informed Council that Ordinance #12848 had been confused with another zoning ordinance whose petitioner asked to be withdrawn. Mr. Bridger asked Council to consider Ordinance #12849 again next week. **Councilman Grohn moved** to defer one (1) week, seconded by Councilman Hakeem. **The motion carried.**

**Councilman Freeman moved** to consider [the following] ordinance to the end of the agenda. He was seconded by Councilman Mitchell. **The motion carried.** The reading of the following ordinance was moved on the agenda.

#### **ORDINANCE #12850**

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 25, ARTICLE III, SECTIONS 25-67, 25-69, 25-73, AND 25-75, RELATIVE TO UNLAWFUL NOISES.

After the reading, Attorney Hinton opened a discussion by noting that there were several amendments for Council consideration.

Regarding the district name, **Councilman Gilbert moved** to amend and name the area as "Downtown Amplified Music District," seconded by Vice Chair Dr. Berz. A discussion ensued. **The motion carried** upon roll call vote as follows:

Regarding boundaries, **Chairman Henderson moved** to amend the Downtown Amplified Music District boundary so that the Market Street and Broad Street corridors will continue until 7<sup>th</sup> Street. He was seconded by Councilman Mitchell. A discussion ensued, with Councilman Anderson expressing opposition. **The motion carried** upon roll call vote as follows:

Councilman Mitchell moved to amend Councilman Freeman's motion by adding "railroad tracks west of Adams Street." Councilman Smith seconded again. **The motion carried** upon roll call vote:
