

City Council Building Chattanooga, Tennessee **COUNCIL MEETING MINUTES** November 11, 2014 6:00 PM

## CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order with Vice Chair Dr. Carol Berz and Councilpersons Chris Anderson, Moses Freeman, Russell Gilbert, Yusuf Hakeem, Jerry Mitchell and Ken Smith all present. Deputy City Attorney Phil Noblett, Management Analyst Randy Burns and Deputy Clerk Nicole Gwyn, CMC, were also present. Councilman Larry Grohn was not present.

## PLEDGE OF ALLEGIANCE

Councilman Freeman led the Pledge of Allegiance. Afterwards, he reminded the Assembly of today's national observance of Veteran's Day. He asked the Assembly to "remember in our prayers" the homeless veterans in our community. Chairman Henderson asked all veterans to stand in special recognition.

## SPECIAL PRESENTATION

Greg Haynes, Regional Planning's Director of Development, discussed the two (2) conditions that had been added in the alternate version on the agenda. **Councilman Anderson moved** to amend by adding the wording, "...only be used for a hotel or residential use for no less than 20 years," to the Certificate of Occupancy. Councilman Hakeem called a *Point of Clarity* and inquired of the Applicants if they were in agreement with the amendment.

Chairman Henderson ruled by allowing the Applicants to speak at this time and recognized the following speakers:

- Craig Peavy (Architect)

A discussion ensued with the Applicants and Mr. Bridger regarding retail space on the property. After working through the language with all parties, Attorney Noblett offered the following wording:

- "The property shall be used as a boutique hotel or residential use for a period of not less than twenty (20) years."
- "Retail is permissible on the first floor."

**Councilman Anderson moved** to accept the revised language as an amendment to his amendment for the alternate version. He was seconded by Councilman Mitchell. Councilman Freeman called the question. **Councilman Anderson moved** to approve the ordinance as amended. He was seconded by Councilman Hakeem.

Chairman Henderson afforded an opportunity for Mr. Haniszewski to make a rebuttal. After which, Councilman Freeman questioned Mr. Ball about the history of the R-2 zoning in this area. After further discussion, the Applicant and the Opposition came to an agreement regarding the condition of *"30-foot setback from the building."* 

**Councilman Mitchell moved** to defer one (1) week, seconded by Councilman Freeman. The motion carried.

A discussion ensued with Attorney Noblett about two (2) alternate versions of this ordinance that were distributed to Council. **Councilman Mitchell moved** to amend the alternated version prepared by the City Attorney's Office ("red-lined" version).

**Councilman Freeman moved** to approve the redlined version of this ordinance. He was seconded by Vice Chair Dr. Berz. Chairman Henderson recognized the following speakers:

- Mike Mallen (Chair, Animal Control Board)

Councilman Freeman called a *Point of Order*. He objected, stating that there was a motion already on the floor and that Council did not have to hear from any other governmental body at this point in the debate. Chairman Henderson ruled to allow Mr. Mallen to address Council since there were still questions from Council on this ordinance.

A discussion ensued with Mr. Mallen about why hobby breeders are included certain portions of the permit process. After Mr. Mallen's response, Councilman Mitchell withdrew his amendment to the redlined version. Upon no further questions, **the motion carried**, **with Councilman Gilbert and Chairman Henderson voting "NO."**

Councilman Hakeem moved to amend with the following language:

SECTION 3. BE IT FURTHER ORDAINED That the City Engineer and City Attorney shall propose an appeals process in addition to the procedure set forth in Division 8 of this Article for Stormwater Management on or before March 31, 2015 which shall be brought to the City Council for consideration at that time.

SECTION 4. BE IT FURTHER ORDAINED That the City Engineer and City Attorney will develop an evaluation process to determine the effectiveness of the Stormwater Management program on or before December 31, 2015.

Vice Chair Dr. Berz seconded the amendments. The motion carried, with Councilman Freeman voting "NO" and Chairman Henderson abstaining.

**Councilman Hakeem moved** to approve the ordinance as amended, seconded by Vice Chair Dr. Berz. **The motion carried, with Chairman Henderson voting "NO."** Councilman Smith requested a roll call vote. Chairman Henderson concurred. **The motion carried 5-to-3 upon roll call vote as follows:**
