

City Council Building Chattanooga, Tennessee COUNCIL MEETING MINUTES January 27, 2015 6:00 PM

CALL TO ORDER

Council Chairman Chip Henderson called the meeting to order with Vice Chair Dr. Carol Berz and Councilpersons Chris Anderson, Moses Freeman, Russell Gilbert, Yusuf Hakeem, Jerry Mitchell and Ken Smith all present. Also present were Deputy City Attorney Phil Noblett and Council Clerk Nicole Gwyn, CMC. Councilman Larry Grohn was not present.

APPROVAL OF LAST MINUTES

SPECIAL PRESENTATION

"Proclamation – Robert Fisher (UTC Student Rhodes Scholar)" Presented by City Attorney Wade Hinton

Attorney Hinton invited UTC student Robert Fisher to the podium and proclaimed the following:

- Whereas: Robert A. Fisher, a senior and Brock Scholar at the University of Tennessee at Chattanooga (UTC), is one of thirty-two American men and women chosen as a 2015 Rhodes Scholar; and
- Hereas: Rhodes Scholars are chosen not only for their outstanding scholarly achievements, but for their character, commitment to others and to the common good, and for their potential for leadership in whatever domains their careers may lead; and
- Dereas: Robert majors in Political Science and minors in History and Africana Studies. He has been named a Truman Scholar. He is serving his second terms as Student Government Association President at UTC, was appointed as student representative to the Tennessee Higher Education Commission, and is a Presidential Fellow at the Center for the Student of the Presidency and Congress; and

Derreas: Robert is also the co-chair of Chattanooga Forward's Downtown task force. He was appointed due to his combination of inclusive values and ability to motivate people.
