#### **ELECTION OF CHAIR AND VICE CHAIR**

## **Council Election of Officers: Chair**

Councilman Gilbert nominated Carol Berz as Chair of the Council. Councilman Hakeem seconded. **Councilman Freeman moved** to close the nominations. There was no dissent. Chairwoman Berz was elected upon unanimous acclamation. She expressed her thanks to Councilman Henderson for his past leadership.

# **Council Election of Officer: Vice Chair**

Councilman Smith nominated Moses Freeman as Vice Chair of the Council. Councilman Hakeem seconded. **Councilman Anderson moved** to close the nominations and move for acclamation. Councilman Grohn voted "NO." All other Council members were in favor. Councilman Freeman thanked Councilman Smith for the nomination and thanked the Council for their confidence in him.

Attorney Noblett presented gavels to Councilman Henderson and Chairwoman Berz, who expressed words of thanks to her colleagues.
