John Bridger, Executive Director of Regional Planning, stated that five (5) conditions had been added to this ordinance since last week and read them into the record:

- 1. Retention of existing buildings on the site;
- 2. No dumpsters permitted;
- 3. Signs incident to the permitted uses, except that only one monument-type sign shall be permitted for each structure, which sign shall be set back 10-feet from any property line; the sign shall not exceed 48-square feet in area and shall not be more than 4-feet in height; if illuminated, the sign shall be indirectly lit in such a way that the light source cannot be seen from any public way or adjoining property; the lighting intensity shall not exceed 25-foot candles at the face of the sign; no flashing or intermitted lights shall be permitted; no internally-illuminated signs shall be permitted.
- 4. No surface parking between the structure and primary street, paving of the area between the structure, and the primary street shall be limited only to approved access drives.

5. All exterior lighting shall be of a residential type and style; no commercial fixtures shall be allowed. If residential-style fixtures are mounted on single posts, then no post shall be more than 6-feet in height.

The Applicant was present and indicated their agreement with the stated conditions. No Opposition was present. The motion carried.
