# **COUNCIL MEETING MINUTES**

August 4, 2015 6:00 PM

#### CALL TO ORDER

Council Chairwoman Carol Berz called the meeting to order with Vice Chair Moses Freeman and Council members Chris Anderson, Russell Gilbert, Larry Grohn, Chip Henderson, Jerry Mitchell and Ken Smith all present. City Attorney Wade Hinton and Council Clerk Nicole Gwyn, CMC, were also present. Councilman Hakeem was not present.

# PLEDGE OF ALLEGIANCE

Councilman Anderson led the Assembly in the Pledge of Allegiance and invited Pastor Mike Fulbright of The Well Church to lead the invocation.

# APPROVAL OF LAST MINUTES

On motion of Councilman Anderson and seconded by Councilman Gilbert, the minutes of the last meeting (July 28, 2015) were approved as published.

# SPECIAL PRESENTATION

# Akron, OH Res. 233-2015 By Chairwoman Berz

Chairwoman Berz read the following resolution passed by the City Council of the Akron, OH:

**RESOLUTION NO. 233-2015** expressing the sincere sympathy and heartfelt condolences of the City of Akron to the families of the servicemen killed in the attack on a recruitment center and the Navy Operational Support Center in Chattanooga; condemning the senseless act of violence that took the lives of three war veterans, a young Naval Officer, and a young Marine; and declaring an emergency.

**WHEREAS**, on the afternoon of July 16, 2015, an armed gunman opened fire on a military recruitment center in Chattanooga, Tennessee, then drove six miles to the Navy Operational Support Center where he killed four marines, gravely wounded another, who later died, and injured two others; and

**WHEREAS**, the fatally wounded victims of these attacks were all servicemen, beloved husbands, fathers, sons and brothers, whose lives were stolen from them and their families too soon; and

**WHEREAS**, these men answered the call to serve their country and heroically accepted the risk of losing their lives in protecting and defending the freedom of others, but could not have predicted that they would have been killed in such a way-at home, on American soil, in an act of senseless hate and violence; and

**WHEREAS**, others were injured in the attacks, including a police officer and military recruiter; and

**WHEREAS**, the federal government has initiated a domestic terrorism investigation based on the particular facts and circumstances surrounding the event and the behavior of the suspect, who was himself killed in the course of the violence; and

**WHEREAS**, the brave first responders and law enforcement officers in Chattanooga who responded to the attacks acted quickly to save additional lives and prevent further violence by the gunman; and

**WHEREAS**, the City wishes to express its deepest sympathy to the families of the victims and the community of Chattanooga, to extend heartfelt wishes for healing, peace, and understanding in the face of this terrible tragedy, and to express its most sincere gratitude for the victims' service to their country.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Akron:

**Section 1.** That the Council hereby expresses the sincere sympathy and heartfelt condolences of the City of Akron to the families of the servicemen killed in the attack on a recruitment center and the Navy Operational Support Center in Chattanooga, and condemns the senseless act of violence that took the lives of three war veterans, a young Naval Officer, and a young Marine.

**Section 2.** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare for the reason that it is necessary and appropriate for Council to express its sympathy to the families of the victims of this attach, and provided this resolution receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.

# Agenda Item 7(a)

A resolution authorizing the Chief of the Chattanooga Fire Department to apply for and, if awarded, accept grants under \$10,000.00 only if the grants do not require matching city funds, and the Fire Department will apply for these grants without Council approval and those awarded will be reported to Council.

Councilman Henderson moved to approve, seconded by Councilman Anderson. The motion carried.

During the same meeting, **Vice Chair Freeman moved** to reconsider agenda item 7(a) [Resolution #28348] so that the Council might deliberate on extending the resolution to all city government. Councilman Anderson seconded. The motion carried.

Vice Chair Freeman moved to delete and substitute item 7(a) with the following language:

# **RESOLUTION #28348**

A RESOLUTION AUTHORIZING THE ADMINISTRATORS AND DIRECTORS OF THE CITY OF CHATTANOOGA TO APPLY FOR AND, IF AWARDED, ACCEPT GRANTS UNDER TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) ONLY IF THEY DO NOT REQUIRE MATCHING FUNDS AND DO NOT PLACE OPERATIONAL OBLIGATIONS ON THE CITY, AND THOSE GRANTS AWARDED WILL BE REPORTED TO THE CITY COUNCIL NOT LESS THAN ON A QUARTERLY BASIS.

Councilman Anderson seconded. A discussion ensued with Brent Goldberg, Chief Operating Officer, regarding the change in the amount from \$10,000 to \$25,000. Upon no further discussion, Councilman Anderson called the *question*. The motion carried.
