**AN ORDINANCE TO AMEND PART II, CHATTANOOGA CITY CODE, CHAPTER 35, ARTICLE VII, DIVISION 2, SECTION 35-247, RELATIVE TO REQUIREMENT EQUIPMENT OF PEDAL CARRIAGE OR PEDICABS AND SECTION 35-252 RELATIVE TO THE RESTRICTIONS ON THE OPERATION OF PEDAL CARRIAGE OR PEDICABS.**

Eston and Tammy Mayberry made a presentation regarding pedal carriages or pedicabs. They, along with two other partners, will operate a pedal carriage company in Chattanooga.
