

## ORDINANCE NO. 11596

AN ORDINANCE AMENDING ORDINANCE NO. 11563, ADOPTED JUNE 1, 2004, CLOSING AND ABANDONING AN UNOPENED PORTION OF THE 3300 BLOCK OF CRESTFIELD DRIVE, AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, BY CORRECTING THE PROPERTY DESCRIPTION.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF

CHATTANOOGA, TENNESSEE, That Ordinance No. 11563 be and is hereby amended so as to

close and abandon an unopened portion of the 3300 block of Crestfield Drive by deleting the

property description in its entirety and substituting in lieu thereof the following description with

any and all conditions remaining in full force and effect:

To mark the beginning point, begin in the west right-of-way line of Eastwood Avenue intersected by the north right-of-way of Crestfield Drive; thence N.66°41'W a distance of 25 feet to the point of beginning; thence N.66°41'W a distance of 201.6 feet to the west line of Lot 10, Eastwood View Estaes, Plat Book 72, Page 182, R.O.H.C. Said right-of-way separates Lot 10 of said subdivision from Lot 1, Foxwood Plaza Subdivision, Plat Book 43, Page 160, R.O.H.C. Tax Map Nos. 137P-M-008.08 and 137P-N-008.

SECTION 2. BE IT FURTHER ORDAINED, that this Ordinance shall take effect two


