ORDINANCE NO. <u>11747</u>

AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO REZONE A TRACT OF LAND LOCATED AT 6390 LEE HIGHWAY, MORE PARTICULARLY DESCRIBED HEREIN, FROM R-4 SPECIAL ZONE TO C-2 CONVENIENCE COMMERCIAL ZONE, SUBJECT TO CERTAIN CONDITIONS.

- 1. All points of ingress and egress shall be reviewed and approved by the City Traffic Engineer;
- 2. All lighting is to be directed away from any abutting residential zones (excluding R-4) and be designed to reflect downward so as not to create or add to light pollution; and
- 3. The following uses shall be prohibited: adult-oriented establishments or teenage clubs stand alone; car washes; automobile dealerships, used car lots or any use with outdoor storage or display; outdoor amusements; billboards; mini-warehouses; travel trailer camps; alternative financing establishments; pawn shops; bowling alleys; skating rinks and billiard

4. Convenience stores, service stations and restaurants with drive-thru facilities must be reviewed by the pre-submittal committee.
