AN ORDINANCE CLOSING AND ABANDONING PORTION OF THE 700 BLOCK OF WALL STREET AND THE 900 BLOCK OF 1 MAGNOLIA -ALLEY, MORE PARTICULARLY DESCRIBED HEREIN AND AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

<u>SECTION 1</u>. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That there be and is hereby closed and abandoned a portion

of the 700 block of Wall Street and the 900 block of Magnolia Alley, more particularly described

below and as shown on the map attached hereto and made a part hereof by reference:

Abandonment of a portion of the 700 block of Wall Street beginning at the southwest corner of Tax Map 145E-J0016 thence extending some 46 feet southeast to the west line of the 900 block of Magnolia Alley. Said street separates part of Lot 29 from part of Lot 30, Block 1, Hodges Addition to Park Place, Plat Book 1, Page 2, ROHC. Tax Map 145E-J-016 and 017.

Abandonment of a portion of the 900 block of Magnolia Alley beginning at the northeast corner of Tax Map 146H-N-033 thence extending some 52 feet to a dead-end. Said street separates part of Lot 30 from Lot 23 and 24, Block 1, Hodges Addition to Park Place, Plat Book 1, Page 2, ROHC. Tax Map 145E-J-016, 146H-N-027 and 033.

<u>SECTION 2</u>. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to:

1. The City of Chattanooga, BellSouth, Comcast, and the Chattanooga Gas Company retaining their respective easements for the full width of the right-of-way; and

2. Construction of a cul-de-sac by Chattanooga Neighborhood Enterprise.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two


