(2) weeks from and after its passage.



Re: Franklin Associates Architects, Inc.- Case No. 2007-095 710 East 4th Street Recommendations for ROW/ Sanitary Sewer Easement Abandonment

I have completed the review of Franklin Associates Architects' request for Abandonment of the portion of the ROW/ Sanitary Sewer Easement Abandonment (Sewer Line # 7048). The abandonment is for a portion of the existing sewer line and the manhole as indicated on the attachment. My comments are as follows:

- 1. Existing sanitary sewer is to be replaced by the property owner with the proposed replacement as submitted to and approved by Eric Douglas, Construction Inspector Supervisor in the City's Land Development Office.
- 2. There are no objections to the abandonment in written form.
- 3. At this time, construction on the replacement sewer line is not underway. The existing sewer line is still live. All new ROW/ Sanitary Sewer Easement paperwork must be completed for the new sewer line.

After review abandoning the above mentioned ROW does not conflict with the Public's interest.

Therefore, I recommend that the request for abandonment be approved with the following conditions:

- 1. The construction on the replacement sewer line be completed according to the plans
- as submitted to and approved by the City, with the new sewer line accepted and inspected by the City.
- 2. The abandoned sewer line must be properly capped and/or removed according to the regulations as set forth by the Tennessee Department of Environment and Conservation.
- 3. All new sanitary sewer easement information must be platted and recorded.

Final Sanitary Sewer Abandonment will not be approved until all above stated conditions have been met.
