Abandonment of a sewer easement between manhole #176 thence extending 235 feet southwest, being located on Lots 2 thru 4 and 6 thru 8 of the Final Plat of Missionary Ridge Homes, Plat Book 57, Page 376, ROHC. Tax Map 156E-A-025.02 thru 025.04 and 025.06 thru 025.08.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to the conditions on the attached Memorandum.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.







Unit Block of Laurel Ave. and 200 Block of Ridge Ave. Recommendations for Requested ROW Abandonment

I have completed the review of the City of Chattanooga's request for two ROW / Sanitary Sewer Easement Abandonment's, the first being between manhole #1 and manhole #3, being 285' ± and being located in the former west right-of-way of the unit block of Laurel Ave. being currently Tax Map 156E-A-025 as shown on attached map. The second being between manhole #176 thence extending 235' ± southwest, being located on Lots 2 thru 4 and 6 thru 8 of the final plat of Missionary Ridge Homes (Plat Book 57, Page 376), Tax Map 156E-A-025.02 thru 025.04 and 025.06 thru 025.08. My comments are as follows:

- 1. Existing sanitary sewer is to be replaced by the property owner / applicant with the proposed replacement as submitted to and approved by the Construction Inspector in the City's Land Development Office.
- 2. There are no objections to the abandonment by Public Interest and or Utility Owners.
- 3. At this time, construction on the replacement sewer line is not underway. The existing sewer line is still live.

After review abandoning the above mentioned ROW / Sanitary Sewer does not conflict with the Public's interest.

Therefore, I recommend that the request for abandonment be approved subject to a suitable replacement sanitary sewer line. All ROW / Sanitary Sewer Easement paperwork must be completed for the new sewer line and it must be recorded (video). In addition, as-built plans are to be submitted and approved by the Land Development Office and the City Engineer.
