ORDINANCE NO. 12113

AN ORDINANCE TO AMEND CHATTANOOGA CITY CODE,
PART II, CHAPTER 24, SECTION 24-504, SCHEDULE IV,
ONE-WAY STREETS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA,
TENNESSEE:

SECTION 1. The Chattanooga City Code, Part II, Chapter 24, Section 24-504, Schedule IV, One-Way Streets, be and the same is hereby amended to add the following one-way streets:

Hemlock Circle, north bound from Rose Circle to Myrtle Avenue.

Donna Lane, south bound from Buena Vista Drive to Clearview Avenue; and

Tampa Street, north bound from Frazier Avenue to 250 feet north of Frazier Avenue.

SECTION 2. The Chattanooga City Code, Part II, Chapter 24, Section 24-504, Schedule IV, One-Way Streets, be and the same is hereby amended to remove the following one-way streets:

Cemetery Avenue, westwardly from Central Avenue to Main Street;

Cherry Street, northwardly from Eighth Street to Fourth Street;

Eleventh Street, eastwardly from Carter Street to Market Street;

Fortwood Place, southwardly from Oak Street to McCallie Avenue;

Foundry Alley, eastwardly from Fairview Avenue to Central Avenue;

Ninth Street, eastwardly from Georgia Avenue to Central Avenue;

Ridge Avenue, northwardly from Sherwood Road to Crest Road;

Second Street, eastwardly from Walnut Street to Lookout Street;

Tenth Street, westwardly from Market Street to Carter Street;

Thirty-Fourth Street Circle, northerly, eastwardly, and southerly from driveway entrance north of Thirty-Fourth Street;

Twenty-Fifth Street, westwardly from Williams Street to Broad Street;

Twenty-Sixth Street, eastwardly from Broad Street to Long Street;

Washington Street, northwardly from East Twenty-Fifth Street to Poss Drive;

Fifth Street, westwardly from Georgia Avenue to Market Street; and

Kellys Ferry Road, northwest from Browns Ferry Road to Aster Avenue.

SECTION 3. The Chattanooga City Code, Part II, Chapter 24, Section 24-504, Schedule IV, One-Way Streets, be and the same is hereby amended by deleting the description for Elinor Lane and the first Manning Street description and substituting in lieu thereof the following:

Jadie Lane, an alley extending southwardly from Colville Street to East Manning Street; and

Manning Street, northeastwardly from Tucker Street to Jadie Lane.

SECTION 4. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.


