ORDINANCE NO. <u>12472</u>

AN ORDINANCE TO AMEND ORDINANCE NO. 6958, AS AMENDED, KNOWN AS THE ZONING ORDINANCE, SO AS TO LIFT CONDITIONS 1 AND 2 IMPOSED IN ORDINANCE NO. 11290 AND TO AMEND CONDITION 1 IMPOSED IN ORDINANCE NO. 11372 ON PARTS OF PROPERTIES LOCATED AT 706 ASHLAND TERRACE, BEING MORE PARTICULARLY DESCRIBED HEREIN, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Ordinance No. 6958, as amended, known as the Zoning Ordinance, be and the same hereby is amended so as to lift conditions #1 and 2 imposed by Ordinance No. 11290 so as to include the use of mini warehouses and outdoor storage and remove the 2.5 spaces per 1000 feet requirement and also to amend condition 1 imposed in Ordinance No. 11372 to include mini warehouses (indoor) and outdoor storage facilities on parts of properties on the located at 706 Ashland Terrace and an unaddressed parcel to the east being Tax Map No. 109O-E-010.

All those parts of two unplatted tracts of land which are currently zoned C-2 with conditions and being parts of the properties described in Deed Book 6083, Page 558, ROHC. Tax Map Nos. 109O-E-008(part) and 010(part).

<u>SECTION 2</u>. BE IT FURTHER ORDAINED, That this rezoning shall be approved as follows:

1. Approved, amending condition number 1 of Ordinance No. 11290 to include mini-warehouses. Deny lifting condition number 1 for outdoor facilities;

2. Approve lifting condition number 2 of Ordinance No. 11290, subject to 2.5 parking spaces per 1,000 square feet.

3. Approve amending condition number 1 of Ordinance No. 11372 to include mini-

warehouses, subject to certain conditions:

- a) Offices with associated indoor storage and miniwarehouses only.
- b) Keep the existing condition of additional Leyland cypress
 @ 15' on center inside the existing natural buffer per Ordinance No. 11372, except where sanitary sewer or EPB easement exists; for both easements, use alternate Type C buffer consisting of a double row (staggered) of screening shrubs spaced a maximum of 7' on center, to be installed at a minimum height of 36".
- c) Provide tree protection fencing on site during construction to protect the integrity of the natural buffer.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two


