ORDINANCE NO. 12698

AN ORDINANCE CLOSING AND ABANDONING OF A PORTION OF RIGHT-OF-WAY IN THE 5100 BLOCK OF OLD HIXSON PIKE BEGINNING AT THE INTERSECTION OF NORTHPOINT BOULEVARD AND OLD HIXSON PIKE, MORE PARTICULARLY DESCRIBED HEREIN, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That a portion of right-of-way in the 5100 block of Old Hixson Pike beginning at the intersection of Northpoint Boulevard and Old Hixson Pike, along the east right-of-way line of Old Hixson Pike thence going northeast along Old Hixson Pike for some 98 feet as shown on the Final Plat of Houston Hixson Home Place, Lot 1, not yet recorded with intersection, more particularly described herein, and as shown on the map attached hereto and made a part hereof by reference, be and is hereby closed and abandoned:

Abandonment of a portion of the 5100 block of Old Hixson Pike right-of-way beginning at the intersection of Northpoint Boulevard and Old Hixson Pike along the east right-of-way line of Old Hixson Pike thence going northeast along Old Hixson Pike for some 98 feet as shown on the Final Plat of Houston Hixson Home Place, Lot 1, not yet recorded. Tax Map No. 100O-B-013.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to the retention of drainage and utility easements and routing rights for the City of Chattanooga, Hixson Utility District, Comcast, and AT&T and for approval of the final plat by the City Engineer.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two (2) weeks from and after its passage.

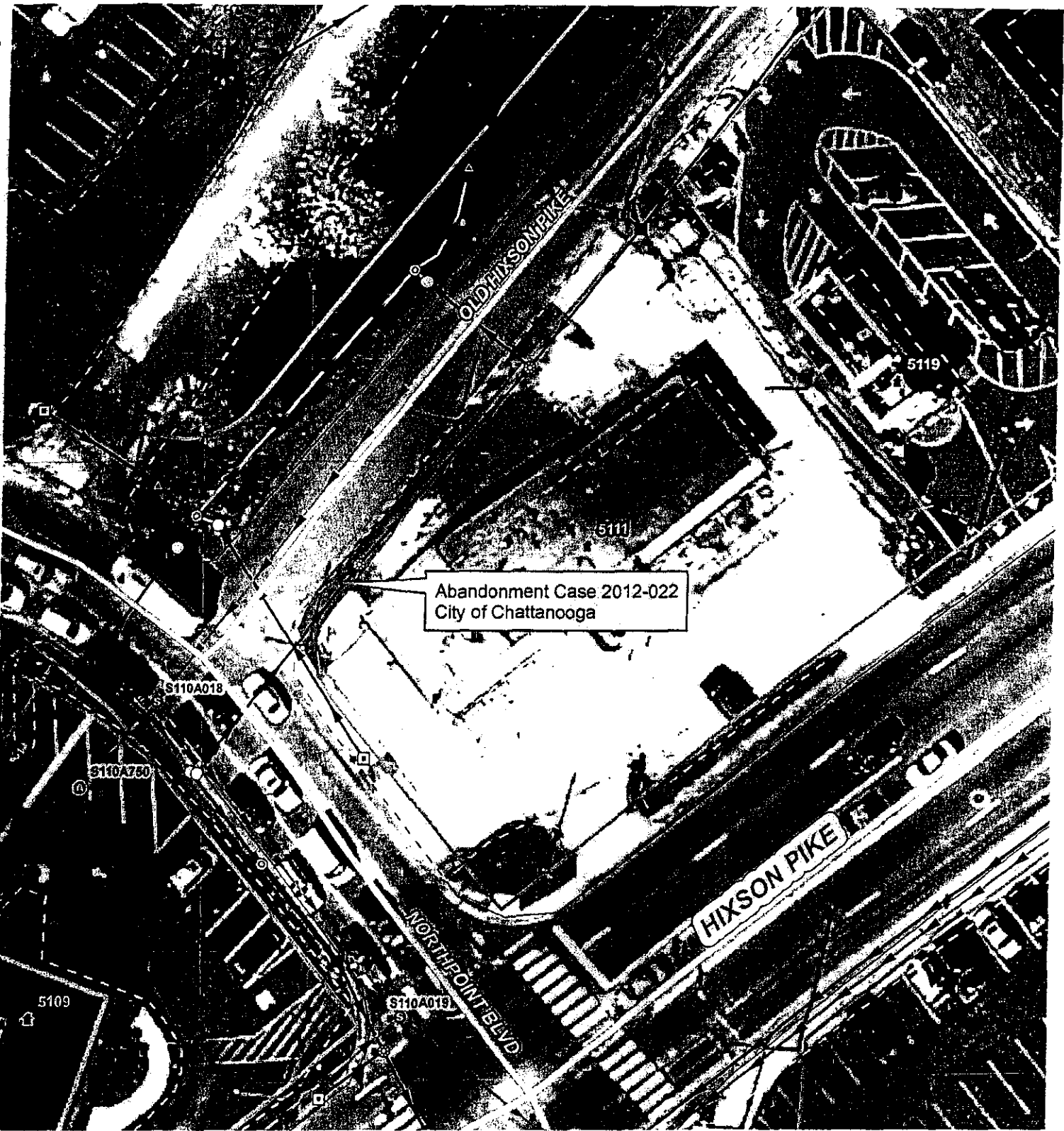
