ORDINANCE NO. 12772

AN ORDINANCE CLOSING AND ABANDONING AN UNOPENED ALLEY BEGINNING AT ITS INTERSECTION WITH THE NORTH LINE OF THE 2600 BLOCK OF EAST 24<sup>TH</sup> STREET NORTHEAST SOME SIXTY-FIVE (65') FEET TO THE NORTHEAST CORNER OF TAX MAP NO. 156K-B-001, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That an unopened alley beginning at its intersection with the north line of the 2600 block of East 24<sup>th</sup> Street northeast some sixty-five (65') feet to the northeast corner of Tax Map No. 156K-B-001, more particularly described herein, and as shown on the maps attached hereto and made a part hereof by reference, be and is hereby closed and abandoned:

Abandonment of a part of an unopened alley beginning at its intersection with the north line of the 2600 block of East 24<sup>th</sup> Street thence northeast some 65 feet to the northeast corner of Tax Map 156K-B-001. Said alley separates Lots 11 and 12 from Lots 13 and 14, The Curtis Addition to Ridgedale, Plat Book 2, Page 12, ROHC. Tax Map Nos. 156K-B-001 and 002.

SECTION 2. BE IT FURTHER ORDAINED, That this closure and abandonment shall be subject to the retention of a Comcast utility easement for the full width and length of the subject portion of the said alley.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two  
(2) weeks from and after its passage.

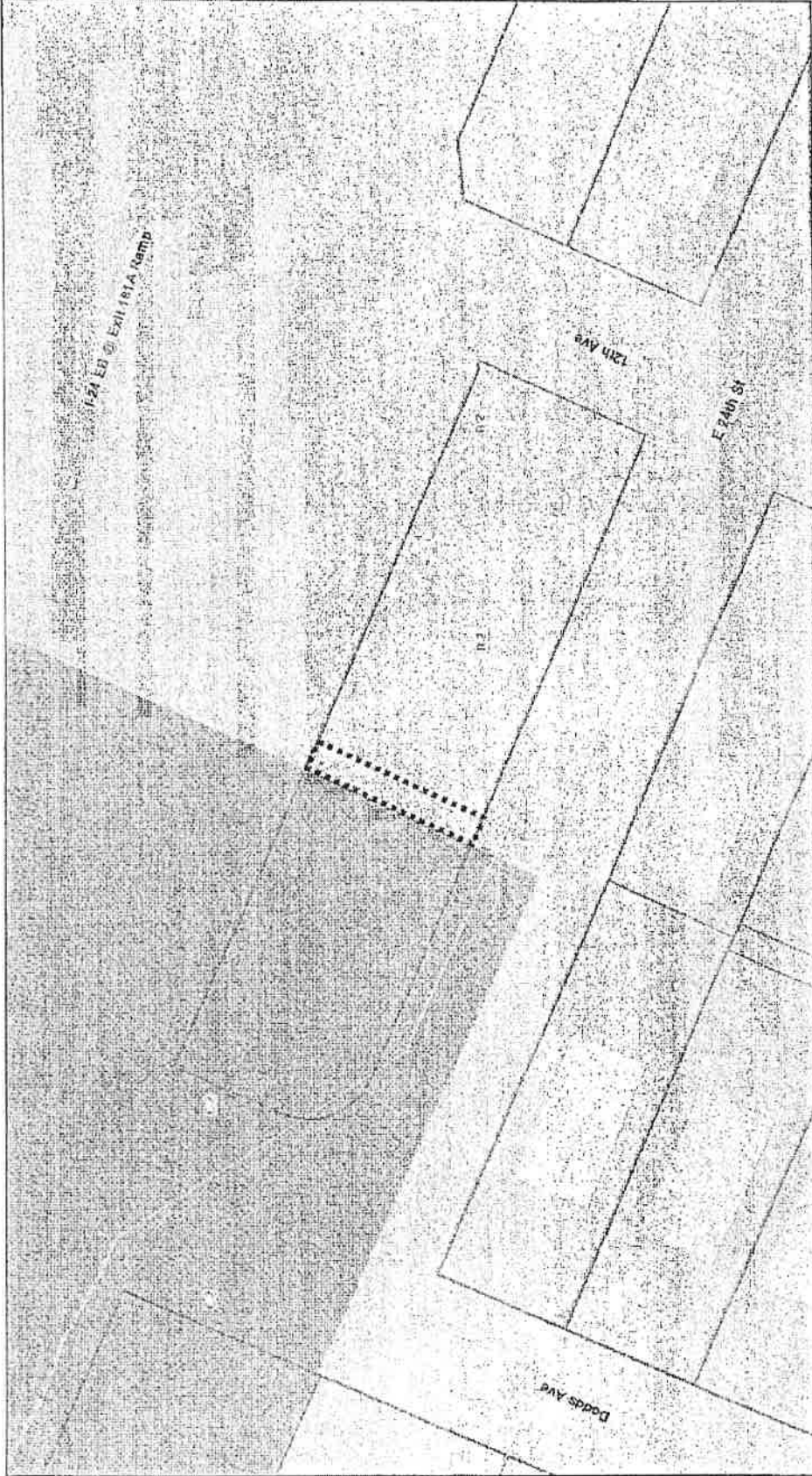

## MR 2013-056 Abandonment of an Unopened Alley in the 2600 blk of East 24th St

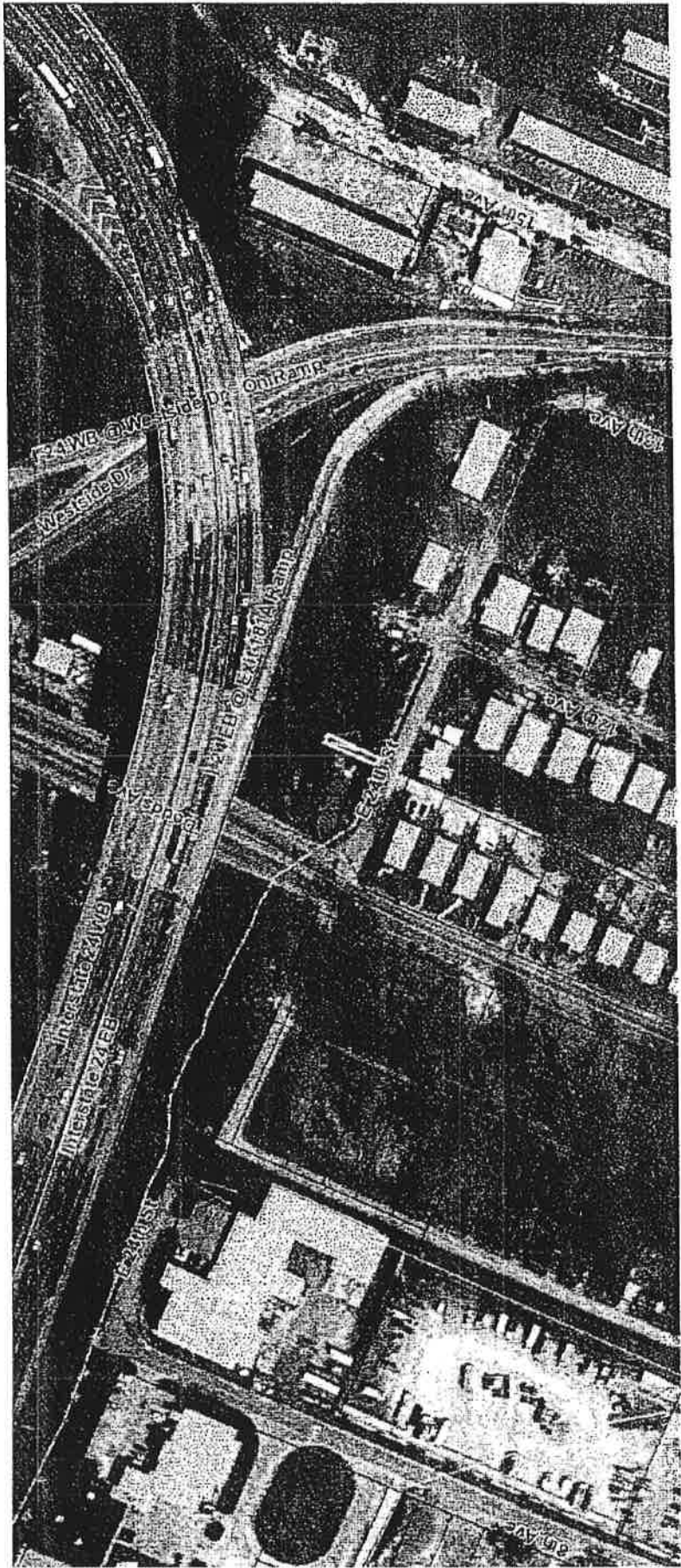


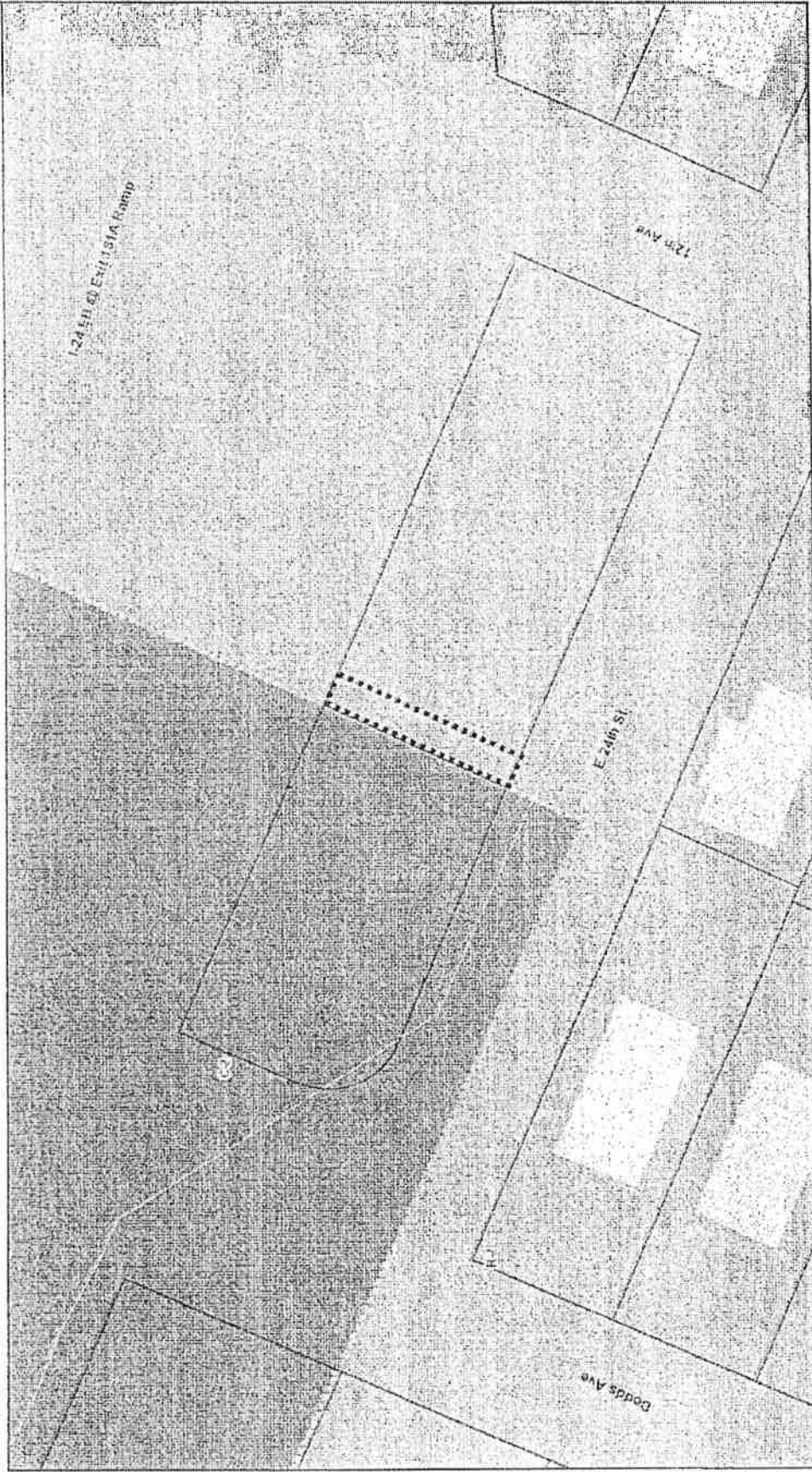
