

RESOLUTION NO. 25928

A RESOLUTION AMENDING RESOLUTION NO. 25834 BY CHANGING THE AMOUNT OF FISCAL YEAR 2009-2010 COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME INVESTMENT PARTNERSHIP ACT FUNDS TO BE AWARDED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AND PROGRAM INCOME FROM A TOTAL OF THREE MILLION EIGHT THOUSAND DOLLARS (\$3,008,000.00) TO A TOTAL OF THREE MILLION FIVE HUNDRED TWENTY-NINE THOUSAND FIVE HUNDRED TWENTY-NINE DOLLARS (\$3,529,529.00); CHANGING THE AMOUNT OF EMERGENCY SHELTER GRANT FUNDS TO BE AWARDED BY THE TENNESSEE HOUSING DEVELOPMENT AGENCY (THDA) FROM EIGHTY-FIVE THOUSAND DOLLARS (\$85,000.00) TO EIGHTY-FOUR THOUSAND DOLLARS (\$84,000.00); AND CHANGING THE DISTRIBUTION OF THE FUNDS AS SHOWN MORE FULLY HEREINBELOW.

WHEREAS, by Resolution No. 25834, on February 24, 2009, the City Council of Chattanooga,, Tennessee authorized the acceptance and distribution of fiscal year 2009-2010 Community Development Block Grant and HOME Investment Partnership Act Funds from the U.S. Department of Housing and Urban Development (HUD) and program income, all totaling approximately Three Million Eight Thousand Dollars (\$3,008,000.00), and further authorized acceptance, and if awarded, the distribution of Fiscal Year 2009-2010 Emergency Shelter Grant Funds from the Tennessee Housing Development Agency (THDA) in the approximate amount of Eighty-five Thousand Dollars (\$85,000.00), as shown on the schedules below, subject to approval by HUD and THDA respectively; and
