### **PUBLIC HEARING NOTICE**

PLEASE TAKE NOTICE the City of Chattanooga, Tennessee, hereby provides certain financial information for public hearing regarding an amendment to the Fiscal Year 2020-2021 capital budget Ordinance No. 13559 in accordance with the requirements of Tennessee Code Annotated Title 6 Chapter 56, Part 2. Therefore, the City of Chattanooga's "The Fiscal Year 2020-2021 Capital Budget Ordinance," as more fully described below, will come before the City Council of the City of Chattanooga for a public hearing on September 15, 2020, and for first reading on Tuesday, September 22, 2020, during the 6:00 p.m. EDT (local time) meeting, and for second and final reading on Tuesday, September 29, 2020, during the 6:00 p.m. EDT (local time) meeting.

AN ORDINANCE TO AMEND CAPITAL IMPROVEMENTS BUDGET ORDINANCE NO. 13559, KNOWN AS "THE FISCAL YEAR 2020-2021 CAPITAL BUDGET ORDINANCE," SO AS TO APPROPRIATE ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00) FROM THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT CAPITAL PROJECT PUBLIC ART IN NEW CAPITAL CONSTRUCTION, TO THE SOUTHEAST TENNESSEE DEVELOPMENT DISTRICT FOR THE ARTISTS WORK PROGRAM AND TO ACCEPT AND APPROPRIATE FIVE HUNDRED THIRTY-ONE THOUSAND THIRTY-SIX DOLLARS (\$531,036.00) ADDITIONAL TRANSPORTATION IMPROVEMENT PROGRAM FUNDS TO TRANSPORTATION CAPITAL PROJECT PAVEMENT MANAGEMENT #2 (CHATT1) FOR THE BAILEY AVENUE AND CHESTNUT STREET TIP PAVING PROJECTS.
