

The first was a 3 ct "round brilliant" cut set in a 14ct white gold band (valued at \$22,299.) This diamond has been microscopically inscribed with GS162400101. The second was a 2.01 ct "Leo Round" cut diamond set in a 14 ct white gold band (valued at \$25,599.) It was inscribed with LEO2129566. The suspect then asked to compare the rings, Ms. McGoy never willingly relinquished control of the diamonds, but showed them to the suspect side by side. At which point the suspect grabbed both rings from her hands and fled through the employee corridor outside the upstairs entrance to Belk. The rings selected by the suspect were the most expensive in their respective cases. Kay does not have in house security cameras. Continuation to follow, once contact with the mall security office is made and security footage of the incident has been reviewed.
